

# TERMS & CONDITIONS

## SUNCORP STADIUM 10<sup>th</sup> BIRTHDAY PROMOTION

### “SLEEPOVER WITH THE STARS”

1. Information on how to enter and prizes form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Terms and Conditions of Entry.
2. Entry is open only to Queensland residents. The major prize can only be redeemed by a person 18 years or older. The guests of the prizewinner must also be 18 years or older.
3. Employees of the promoter (casual and fulltime) and their immediate families, participating outlets and the agencies / partners associated with this promotion (Coca-Cola Amatil, Queensland Reds, Brisbane Broncos and Spotless Services Ltd) are ineligible to enter.
4. To be eligible to win, you must purchase a Coca-Cola product when attending either the Queensland Reds v Melbourne Rebels Super Rugby game at Suncorp Stadium on Saturday 1 June 2013 or the Brisbane Broncos v New Zealand Warriors NRL game at Suncorp Stadium on Monday 3 June, 2013. Upon purchasing a Coca-Cola product at any of the Suncorp Stadium retail outlets, you will receive a scratch-it ticket revealing a prize or no-prize.
5. All prizewinners must contact Suncorp Stadium during business hours (Monday to Friday 9am to 5pm) by Friday 28 June 2013 to arrange the redemption and collection of their prizes. All prizewinners will need to produce their winning scratch-it ticket as proof of their entitlement to a prize. If winners have not contacted Suncorp Stadium by that date, and all attempts by the Stadium to contact them have been unsuccessful, unclaimed prizes will be dealt with as prescribed by the law of the State or Territory of Australia in which the prize winner resides. The major prize remains the property of the Promoter until claimed by the prize winner. The runners up prizes remain the property of Ogden.

The major prize is dinner, beverages and tickets for the winner and three (3) friends in a corporate facility at Suncorp Stadium for the Bon Jovi “Because We Can” Tour concert on Tuesday 17 December 2013. The group of four will sleepover at Suncorp Stadium and will be served breakfast the following morning. The major prize is valued at \$800 a person. 7. The overall promotional period commences on 5pm on Saturday Sunday 1 June 2013 and closes at 10pm on Monday 3 June 2013 (the “entire promotional period”).
8. The Promoter's decision in relation to all aspects of this promotion is final and binding on all who enter and no correspondence will be entered into.
9. The total prize pool is valued at **\$11,290**. Prizes do not include any ancillary costs associated with their redemption. Runners up prizewinners will be responsible for the collection and delivery of prizes.
10. These prizes are not exchangeable and in the event that for any reason whatsoever, the prizes become unavailable, the Promoter reserves the right substitute the prizes (with reference to all relevant State and Territory Rules and Regulations) to other prizes of the same or equal value.
11. The major prize must be redeemed on the day of the concert (Tuesday 17 December 2013).
12. The Promoter reserves the right to disqualify any entrant for tampering with the entry process or conducting any activity which is not in accordance with these Conditions of Entry. The Promoter may in their absolute discretion require that the individual provide photographic identification or some other acceptable form of identification or proof of age before awarding the major prize.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion, including, but not limited to, where arising out of the following:” (a) any theft, unauthorized access or third party interference; (b) any prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (c) any variation in the prize value to that stated in these conditions of entry; (d) any tax liability incurred by a winner or entrant; (e) participation in the promotion and/or (f) redemption of the prize.
